Minutes of SCS Men's Niners Golf Club General Membership Meeting February 22, 2024

On Thursday, February 22, 2024, a general meeting of the Men's Niners, pursuant to notice, was called to order at 10:30 AM. The meeting took place in front of the Palm Valley Pro Shop, following the day's tournament.

The meeting began with Vice President, Louie Medrano, going over a list of upcoming events.
